Meeting Minutes

Dale Huffington, AEØS, presided over the October club meeting. Bill, KFØKC, read the minutes from the last meeting and Doug, NØIKD, delivered the Treasurer's report.

Club Station Antenna Jim Lawler, WYØB, reported that the HF antenna was installed at the club station and seems to be working well. Members who helped out were KFØKC, NØIKD, NØNMB, NØNMM, NØOUT, and NØNKC. The ladder truck and personnel from Columbia Fire Department Station #3 were also on hand to provide a "skyhook" to lift the antenna into place. The club voted to send a letter of appreciation to station #3 thanking them for the assistance. Technical Committee Mike Baker, NØLBA, informed the club that the city of Columbia is improving the RACES facilities at the Joint Communications Center. They are going to purchase a new VHF antenna for the RACES station, which should be a big improvement over the current antenna which is cut for a commercial frequency and consequently has an SWR of about 2.5:1 on 2 meters. The city is also going to provide a replacement computer to be used for the packet station.

RACES On another topic, Mike related that there was some confusion during a recent attempt to call up the RACES members, partly because of equipment problems with the beepers for the RACES members on call. The equipment problems will be checked out during the next month. The was also some discussion concerning recruitment of new RACES members to stand call. RACES personnel need to be available whenever an emergency arises, so it is not a responsibility to be casually assigned. Members who can make this kind of committment and are interested in emergency communications can contact

the Emergency Coordinator, George Hessenbruck, NØIMS, or CMEN Net Manager Ann Guptill, WBØTEG. Club Station Since the new antenna is now available, why not put it to good use? Jim, WYØB, discussed operations during upcoming contests that interested club members could work from the club station. With a good triband beam at 80 feet and an amplifier, the club facility has the potential to be a serious competitor in contest operations. Jim announced that he plans to have the station open on Monday evenings for familiarization with the equipment. Monitor the WDØDVG repeater on Monday evenings for details. Club QSL Cards John Turner, NDØN, announced that he would like to pass on the task of handling club QSL duties. Don Campbell, KBØCDS, volunteered to handle the club QSLs. By informal count, the club has about 50 countries confirmed. so with even modest effort during contests or when the station is open, DXCC for WDØDVG should not be too difficult to obtain.



FCC Clarifies Position on 'Business Communications'

(The following is excerpted from The ARRL Letter)

A recent story in the W5YI Report has created some comment in the amateur community. The story was to the effect that Private Radio Bureau Chief Ralph Haller had spoken at the ARRL National Convention about revisions to FCC Rules and negotiations with the ARRL. The story quoted Haller as stating that the Amateur Radio Service has "excess capacity", taken to mean that there are larger frequency allocations than are needed for routine amateur communications. The story said the extra frequencies could be put to good use by handling messages now transmitted on crowded commercial bands. The story made it appear that the ARRL endorsed the use of amateur bands for commercial activities, which could lead to commercial users making claims on amateur allocations. Clarification of these issues has since been obtained from the ARRL and the FCC.

ARRL Directors attending the Haller speech stated they never heard the phrase "excess capacity", and were assured by the FCC on Oct. 9 that these words were not used, although they had appeared in a draft of Haller's speech and were later edited. Haller indicated that he eliminated the words because of sensitivity to possible misinterpretation. He indicated the term is standard at the FCC and refers

to the capacity of a frequency at different times, and not the the amount of spectrum available.

The discussions about "business communications" refers to the FCC desire for increased public service communications. There have been continuous questions about nonemergency public service and personal affairs in which a business is somehow involved; for example, ordering a tow truck for a diabled motorist vs. ordering a pizza. Other recent questions have arisen about incidents such as the 900 number that was posted on a packet bulletin board, the Iditerod dog sled race in Alaska (in which there were on-air discussions of checkpoint reports and dog food logistics), and messages to an ARRL section manager, some portion of which could appear in OST.

In discussions, the ARRL and the FCC agreed on two key points: 1) strong rules against business messages on amateur bands are necessary to prevent exploitation for nonamateur purposes, and 2) the current rules governing public service may be more strict than necessary. As a result, there has been some discussion of changes to FCC rules that would provide more flexibility in public service and personal communications while still prohibiting communications for hire, for financial benefit of a control operator, or for direct benefit of one's own business or an employer's business. Any rule changes will be considered through normal FCC procedures that require public "Notice and Comment".
