# CMRA Education Committee Meeting Tuesday June 28, 2022, 1900 CDT

### **Minutes**

Attendees: W0ZH (Myron), N0SSM (Jim), & K0ZB (Herb)

**Agenda:** With the elimination of the professional and community education programs offered by the Columbia Public Schools (CPS) through the Columbia Area Career Center (CACC) this committee has been charged by the CMRA membership to create a plan to continue to deliver Amateur Radio education, e.g., Technician Class, to the greater central Missouri area.

**Topics to Cover:** Since the above change has resulted in the loss of all support and resources this committee must effectively create an all-new structure and develop the resources needed to continue this and other educational programs. The committee, at this first meeting, focused on the following three (3) topics:

- 1. Location.
- 2. Registration, including any financial collection.
- 3. Marketing.

### Location:

Brainstorming resulted in the following list of potential locations each with pros and/or cons.

- 1. City or county fire station most do not have meeting space so apparatus floor would have to be used, probably not a good teaching environment. What happens if staff gets dispatched to a call? BCFPD HQ might be an option.
- 2. Private home most not conducive to an educational environment, plus would need to be available for minimum of six (6) consecutive weeks twice a year or more often.
- 3. Boone Electric Cooperative (BEC) building is still under construction and do not know what space and requirements will be.
- 4. CPS or private school proper teaching environment, usually available of an evening, but may require a substantial damage and liability coverage certificate (>\$1 M) which would require a policy.
- 5. Oscher A part of the MU Extension programs, holds in-person classes at the Waters-Moss campus in conjunction with Columbia Parks and Recreation (CP&R). Programs are specifically tailored to those fifty (50) and over. Facilities are owned by CP&R and must be rented.
- 6. Columbia College Educational environment, do not know if available to the community or during the evening hours, or if there would be a charge.
- 7. Emergency Communications Center (ECC) proper classroom on the Emergency Management side. Do not know usage restrictions, availability, or staffing requirements for evening classes over multiple weeks.
- 8. Molly Bowden Police Station north side of Columbia has a community room, but not currently available due to staffing issues.
- 9. Former Potterfield building in Midway donated to the Great Rivers Council, Scouting USA. KF0GUS (Chris Clark) checking on availability.
- 10. Check with ARRL for potential leads on facilities.

# **Registration:**

Registration could be handled on the CMRA website with an appropriate form developed and posted on the website. Data elements to be collected on the registration form need to be defined and form developed and posted. Would need to have an alert sent to one or more individuals for proper responses to the potential student when registration occurs.

Financial collection could be handled with a free Square (or similar) account. Same account could also be used for dues and other member payments. Links would be created by Square but would need to be embedded in the form and/or the appropriate location(s) on the website.
